- Indoor shoes and a water bottle are required at all times (shoes suitable for outdoor use in an emergency)
- All children are recommended to have a change of clothes in their backpacks or cubbies.
- Be aware of all policies and procedures, if you are unsure please ask for clarification.
- Tidy your child's cubby daily and check for center communication.
- Every Friday we require a full cubby clean out as our room is rented out over the weekends.
- Notify SFK of pick-up/drop-off changes daily (admin fees will apply if notice is not given on a regular basis)
- Provide appropriate seasonal attire (winter: Hat, Mitts, Scarf etc. summer: sunscreen, bug spray, hat etc)
- Toys for home are not permitted (unless it is a designated toy or electronic day)
- Please note Pokémon cards are not permitted at Sports for Kids, and are not acceptable for toy days)
